Dear supplier,

The recent changes in national and autonomic legislation (Law 29/2010, August 3rd, regarding the use of electronic forms in the Catalan Public Sector for the promotion of the digital/electronic invoice; and the Spanish Law 25/2013, December 27th, to promote the digital/electronic invoice and the creation of an invoice register in the Public Sector) standardize the duty to submit invoices in its digital/electronic form since January the 15th, 2015.

Henceforth, you will have to send your invoices to e.FACT service from Consorci d'Administració Oberta de Catalunya (AOC) (responsible of the collection and administration of digital/electronic invoices of the Catalan Public Sector). Please find below the link:

Please remember that, in addition to the legal requirements established, the invoices sent must include the service indicator or the provision items in order to manage it accordingly:

- File number (FileReference)
- Request number (ReceiverTransactionReference)
- Delivery note number (DeliveryNote)
